

## **Prize game rules**

### **“Open House Giveaway”**

#### **Article 1 – Organizer**

The organizer of the prize game "Open House Giveaway" (hereinafter "the game") is ForgeBIT d.o.o. (headquarters: Mokrice 172, 49243 Oroslavje, OIB:44406186792) hereinafter referred to as "Compiler" and "Manager of personal data processing".

The raffle is conducted by GYMS4YOU d.o.o. and is the executor of personal data processing, on behalf of the Organizer. (headquarters: Strojarska cesta 20, 10000 Zagreb Croatia, OIB: 75049241440, info@gyms4you.com) hereinafter referred to as "Administrator" of the prize game.

The purpose of the prize game is to promote the gym GYMS4YOU, which is owned by GYMS4YOU d.o.o. companies.

#### **Article 2 – Participants of the prize game**

Game participants (hereinafter "Participant") can be all people over the age of 16 with a residence address in the Republic of Croatia who meet the game conditions.

Employees, owners and management of the Organiser, companies affiliated with the Organiser, Administrators and other companies involved in the raffle, as well as their relatives (spouses, children, and parents and siblings if they live in the same community) cannot participate in the prize draw.

#### **Article 3 – Duration of the prize game**

Duration of the prize game: 21.1.-22.1.2023.

#### **Article 4 - Procedure and conditions for participation in the prize draw**

How to participate: Come to the Open House at Gyms4you center Kvaternik plaza (Maksimirska cesta 8, 10000 Zagreb) on January 21, 2023 (from 9:00 a.m. to 9:00 p.m.) or on January 22, 2023 (from 9:00 a.m. to 9:00 p.m.). 9:00 to 21:00 hours) and write your personal information on a piece of paper

(name, surname, ID number and mobile phone number) which the person will then independently insert into the closed box intended for that purpose. In addition to the above, it is necessary to scan the Technogym QR code, download the Technogym application and create a profile in the Technogym application that allows you to track the Technogym Bench exercises and the rest of the equipment.

Each person has the right to participate in the prize game only once, that is, an individual can only write his name, surname, OIB and mobile phone number on a piece of paper and insert it into the box and download the Technogym application and create a profile in the Technogym application. The right to participate in the prize draw cannot be transferred to other persons.

The raffle is tied to coming to the Open House at the Gyms4you center Kvaternik plaza (Maksimirska cesta 8, 10000 Zagreb) on January 21, 2023 (from 9:00 a.m. to 9:00 p.m.) or on January 22, 2023 (from 09:00 to 21:00 hours).

All participants over the age of 16 who physically came to the Open House at the Gyms4you center in Kvaternik plaza (Maksimirska cesta 8, 10000 Zagreb) on January 21, 2023 (from 9:00 a.m. to 9:00 p.m.) or January 22, 2023 (from 09:00 to 21:00) can take part in the prize game.

To participate in the prize draw, participants should wait until January 23, 2023. to find out if they won a prize.

There is one winner in total.

When receiving the prize, the prize winner is obliged to present his valid identity card at the request of the Administrator in order to determine and confirm the winner's identity.

## **Article 5 - Draw**

The drawing of the winners will be held at the Gyms4you center in Kvaternik plaza (Maksimirska cesta 8, 10000, Zagreb) and will be done based on the random selection of winners by manually drawing slips of paper from the box in which the slips were placed, under the supervision of a three-member commission for drawing the prize.

The draw will take place on January 23, 2023. at 12:00 p.m.

An individual can only participate in the prize draw once, regardless of how many times he came to the Open Weekend at the Gyms4you center in Kvaternik plaza.

All valid entries specified in these Rules, i.e. all persons who came to the Open Weekend at Gyms4you center Kvaternik plaza on January 21, 2023 (from 9:00 a.m. to 9:00 p.m.) or on January 22, 2023 ( from 9:00 a.m. to 9:00 p.m.) and inserted a piece of paper with their name, surname, OIB and mobile phone number into a closed box and downloaded the Technogym application and created a profile on it.

## **Article 6 – Awards**

Reward:

1 x Technogym Bench

Total prize fund value: EUR 1,562.50 including VAT (HRK 11,772.66 including VAT).

Prizes cannot be exchanged for cash, nor are they transferable.

## **Article 7 – Delivery and delivery of prizes**

The drawn winner will be notified by the Administrator in writing within 8 days from the day of the draw in order to agree on the details of receiving the prize and to collect the necessary data for awarding the prize.

The winner will cooperate with the Administrator for the purpose of handing over the prizes and administering all necessary documentation.

The winner becomes entitled to the prize only after the Administrator inspects the identification document, identity card of the winner who has been drawn, or else he loses the right to the prize.

The administrator will secure the prize and will fulfill all legal obligations related to it.

Prizes can only be collected in person.

The prize will be collected by the winner at the Gyms4you center in Kvaternik plaza (Maksimirska cesta 8, 10000, Zagreb) at the agreed time, and no later than 30 days after the announcement of the winner. In the event that the winner cannot collect the prize in the agreed time, the Administrator will make a proposal for another additional time in which it is possible to collect the prize.

As proof of receiving the prize, the Administrator will use a signed confirmation of receiving the prize (receipt/delivery note).

The prize fund in the value of more than HRK 5,000.00 that has not been distributed after the end of the prize draw (after the expiry of the deadline for claiming the prize, interruption of the prize draw, cancellation or putting it on hiatus), the organizer is obliged to sell it at a public tender, and to pay the funds generated by the sale into the state budget within 90 days from the date of expiry of the deadline for withdrawing the prize (Article 69, Paragraph 9 of the Law on Games of Chance and Article 11 of the Ordinance on Organizing Prize Games).

## **Article 8 – Taxes**

The administrator of the raffle, on behalf of the Organizer, undertakes to pay the Red Cross 5% of the established value of the raffle fund before the start of the raffle.

The prize winner is not required to pay any taxes on the prizes.

## **Article 9 - Announcement of the prize draw**

The administrator of the game is obliged to publish these rules on the official Facebook page of the Administrator (<https://www.facebook.com/Gyms4YouHrvatska>) and on the official website of the Administrator (<https://www.gyms4you.com/>) before the start of the prize game, as well as date of issue and license number obtained from the Ministry of Finance.

### **Article 10 - Data processing**

The manager of the processing of the personal data of the prize game participants is ForgeBIT d.o.o., Mokrice 172, 49243 Oroslavje, OIB: 44406186792.

By participating in the prize draw, each participant accepts the rights and obligations from these Rules, and is informed in this regard:

- that his personal data, which are available to the Organizer, are stored in accordance with the General Regulation on the Protection of Personal Data EU 2016/679 and that they can only be used for the purpose of fulfilling the obligations of the Organizer prescribed by the provisions of the Law on Games of Chance (NN 87/09, 35/13, 158/13, 41/14 and 143/14) and the Ordinance on organizing prize games (Official Gazette 08/10). In the form of personal data for the winners of all prizes, the following will be collected: name, surname, mobile phone number and social security number. The organizer will collect mobile phone numbers, first name, last name and social security number from all participants, exclusively for the purpose of notifying them about the prizes won, i.e. determining the correctness of the entry in accordance with the prize game.

- The controller processes the personal data of the prize draw participants exclusively for the purpose of conducting the prize draw in the territory of the Republic of Croatia, limiting the processing to a time period of 120 days, starting from the day of the end of the prize draw specified in the Rules of the prize draw, after which the personal data will be deleted.

By participating in the prize draw, each participant accepts the rights and obligations from these Rules, with the fact that the prize winner also agrees:

- that his personal data, which are available to the Organizer, are stored in accordance with the General Regulation on the Protection of Personal Data EU 2016/679 and the Law on Accounting in connection with the delivery of the prize for a period of 11 years and that the same (name, surname and city only) can be published in connection with the handing over of the prize in articles and reports without any compensation for the purpose of public notification of the results of the prize draw.

Participants expressly agree that their registered personal data will be collected and stored in the database of the Administrator and Organizer of the prize game. In addition, participants agree that the Administrator and the Organizer may manage their personal data without any compensation for the purpose of running this game.

The Administrator and the Organizer process all personal data in accordance with the provisions of the General Regulation on the Protection of Personal Data (EU) 2016/679.

The delivery of data by the raffle participant is voluntary, but necessary in order for the participant to be able to participate in the raffle. In the event that the participant considers that data processing is contrary to the protection of his/her privacy or against the law, he/she may contact the Data Controller and/or request access, deletion or restriction of personal data processing, i.e. exercise his/her right to object to the processing and the right on data portability, by contacting the Controller at any time via the contact of the Personal Data Protection Officer: marko.deak@forgebit.com or send a request to the address of the Controller specified in Article 1 of the Prize Game Rules. With a written request sent to the address of the Data Controller, correction of data and information on data management can be requested, and the participant has the right to withdraw consent at any time, without this affecting the legality of processing that was based on consent before it was she withdrawn. Ultimately, the participants can turn to the Data Protection Agency or the competent court, if they do not agree with the decision or work of the Data Controller.

The manager of personal data processing will not disclose or transfer data to third parties, except entities involved in the implementation of the prize game (delivery service for the delivery of prizes, etc.) and the Ministry of Finance, in accordance with Art. 16 of the Ordinance on the organization of prize games and the notary public who participates in the drawing of winners.

## **Article 11 – exclusion of liability**

The winner can send all requests related to the utility value and quality of the prize directly to the supplier of the prize and the representatives of the brands of the awarded material products.

The organizer will not bear responsibility for material or non-material damage suffered (including actual damage and lost profits), which arise as a result of participating in the prize draw and winning prizes, except for liability that cannot be legally excluded. Članak 12. – Opće odredbe

Participants automatically accept the current official rules by submitting an application to participate in the prize draw.

The organizer has the right to cancel or terminate the prize draw in case of force majeure. The declaration of an epidemic of infectious disease in the territory of the Republic of Croatia or a part of the territory, the declaration of a state of emergency and other measures adopted by the competent state authorities that limit the conduct of the prize draw and/or the awarding and collection of prizes shall be considered as force majeure in particular, but not exclusively.

If any of the above-mentioned circumstances arise, awarding and distribution of prizes will be immediately suspended by a unilateral decision of the Organizer, and the Organizer will publicly announce the reasons that led to the suspension of the drawing and delivery of prizes.

The organizer or any company engaged by the organizer for the execution of the prize draw does not assume responsibility and does not pay any kind of compensation or compensation in relation to costs, damage or loss caused by delays due to deficiencies in the implementation of the prize draw, and during participation in the prize draw.

The Organizer and the Administrator do not assume any subsequent responsibility for the loss of items sent by courier service.

The Organizer will not award any additional prizes other than those specified in these rules.

The administrator shall, within 8 days after the expiration of the period for claiming the prizes, submit to the Ministry of Finance information about the winner of the prize, the name and value of the prize, and proof of receiving the prize (Article 16 of the Rules on organizing prize games).

After 60 days from the end of the prize draw, neither the Organizer nor the Administrator will receive any complaints related to the prize draw.

In the event of a legal dispute between the Organizer and participants, the Municipal Civil Court in Zagreb is competent.
